# Terms & Conditions photography tours & workshops

Please carefully read these terms & conditions before booking any photography tour or workshops with Christian Biemans Photography.

## **Deposit**

A non-refundable deposit of 50% of the total balance is required at the time of booking. After receiving your booking form, you will receive an email with our bank details so you can pay the deposit. After receiving your deposit we will send you an email confirming your place on the workshop or tour.

# Final payment tours

Payment of the total balance of photography tours depends on the tour. You will receive detailed information about the final payment after we have confirmed your place on the tour. Should this payment fail to reach us by the date specified in our confirmation, we reserve the right to cancel your booking. Your deposit will not be refunded.

## Final payment workshops

The balance of workshops has to be paid no later than 4 weeks prior to the start of the workshop. If you are booking within 4 weeks of the start date of the workshop, please send the payment in full. Should this payment fail to reach us by the date specified in our confirmation, we reserve the right to cancel your booking. Your deposit will not be refunded.

### **Payment**

We are able to accept payment by cash or bank/money transfers.

### Cancellation by you

Cancellations will only be accepted if send by email. Your deposit and the balance already paid are non refundable. We strongly advise you to take travel insurance to cover cancellation on your part.

#### Cancellation on our part

We reserve the right to cancel any workshop or tour. If we cancel any workshop or tour on our part we are only obliged to refund your deposit and balance paid.

#### Changes

We reserve the right to change any of the prices, dates, service or other particulars of our workshops and tours at any time should the circumstances force us too. You will be informed about these changes should this occur.

### **Flexibility**

The nature of our tours & workshops is that it requires flexibility and must allow alternatives. For example the locations visited will depend on weather, presence of animals and lighting conditions. For this reason, any outline program of our tours & workshops must be taken as indicative and not as a contractual obligation.

### **Medical condition**

#### Insurance

The insurance must cover the loss, expenses and damages arising from, including but not limited to, cancellation (whether in whole or in part), personal accident and injury, medical and repatriation costs, damage to or loss or theft of belongings and equipment (including camera equipment) loss of baggage and personal money and belongings and flight or ferry cancellations and delays.

## Complaint

If you have a complaint about the tour or workshop, you should make it known at the earliest opportunity and we will endeavor to resolve it. Any outstanding complaint not resolved during the trip should be notified to us in writing within 30 days of the end of the tour or workshop.

# Responsibility & liability

Christian Biemans Photography cannot be held responsible or liable for death, bodily injury or illness caused to the persons on the booking form, unless arising from the negligent act and/or omission of the part of the company. All tours & workshops are entered into at your own risk.

Christian Biemans Photography cannot be held responsible or liable for any loss or additional expenses caused by delay or interruption to travel services through weather conditions, civil disturbance, industrial action, strikes, wars, floods or sickness. Such losses or additional expenses are the responsibility of you and the persons on the booking form.

Any claims shall be subject to Dutch law and all proceedings shall be within the exclusive domain of the Dutch courts.

## Co-hosting

These terms and conditions apply to all the photography tours & workshops organized by Christian Biemans Photography including tours & workshops co-hosted with other photographers. Make sure you have read and understood all Terms & Conditions of all parties included prior to booking.

### Agreement
